Ming Chuan University Guidelines for Approving Community Service Organizations for Service-Learning

- 第一條 銘傳大學(以下簡稱本校)為辦理認證型服務學習,制定本要點。
- Article 1 These procedures were established for Recognition-based Service-Learning stipulated by Ming Chuan University.
- 第二條 本校前程規劃處為推動認證型服務學習,將針對社區非營利機構 進行認證,通過認證之機構可成為本校合作之社區服務機構。
- Article 2 As a means of promoting Recognition-based Service-Learning, the Career Planning and Counseling Division of MCU will approve community non-profit institutions to conduct Recognition-based Service-Learning. Institutions that have been approved may cooperate with MCU and become one of our community service institutions.
- 第三条 社区服务機构認证程序:
 - 一、所有社區機構或非營利組織來函或來電提供服務學習機會。 前程規劃處將主動前往訪視,以進行認證。
 - 二、前程規劃處進行機構訪視與認證的重點為:
 - (一)機構為合法組織及提供之工作內容符合社會公益精神。(二)機構可提供社工員擔任服務學生之督導。
 - 三、符合以上重點者,前程規劃處將與機構簽署「合作協議書」, 並授予認證標章。前程規劃處並將通過認證之社區服務機構 公佈於前程規劃處服務學習網站上,以供查詢。
- Article 3 The approval procedures for community service institutions are as follows:1. Career Planning and Counseling Division welcomes letters and phone calls

from all community institutions or non-profit organizations to provide chances our students an opportunity to do service. Student Affairs Division will pay a visit to the institution as part of the approval process.

- Important points concerning institution visit and approval process by Career Planning and Counseling Division are as follows:
 - (1) The institution is a lawful organization, which provides appropriate job descriptions that are in line with the spirit of civic benefit.

(2) The institution will assign a worker to act as student's supervisor.

- 3. Career Planning and Counseling Division will sign a "Cooperation Agreement" with institutions that meet the above requirements and issue a certificate. Moreover, a list of institutions that have been approved will be announced on the Service-Learning website of Career Planning and Counseling Division for reference.
- 第四條 通過認證之社區服務機構請協助以下事項:

一、至少指定一人擔任學生之督導。

二、確實督導服務學生進行16小時以上之實作服務。

三、指導學生進行回饋反思活動。

Article 4 Approved community service institutions are requested to meet the following requirements:

1. To assign at least one person as student's supervisor.

2. To supervise students as they carry out at least 16 hours of service.

3. To provide guidance on the reflection activities.

- 第五條 本實施要點經行政會議審議通過報請校長核定後施行,修正時亦 同。
- Article 5 Upon being approved by University Affairs Committee and the president, these procedures were announced and implemented. Any revision must follow the same procedure.
